会议主题

新技术下的标准法规之路

序

机动车灯具领域近几年呈现快速的增长趋势，各类新技术和新产品不断涌现。然而产品的快速发展与标准的滞后问题之间的矛盾始终存在，且越来越突出。造成此矛盾的主要原因之一是国内欠缺支撑标准制定的基础研究，机动车灯具领域迫切需要一个持续为标准制定提供技术支撑和输入的平台。

会议主办方作为机动车灯具标准化工作的管理单位，负责组织本领域国家标准和行业标准的制修订工作；同时拥有汽车照明领域最新技术和学术的交流平台，能够聚焦高端、热点和创新技术。两者的结合为打造一个致力于将新技术转化为新标准的平台提供了组织基础。

而今年的中欧汽车灯具标准法规交流会形式与往年不同，今年会议将与第一届国际汽车照明创新技术与标准化高峰论坛紧密结合，国际上邀请具有技术实力引领的汽车照明专家，国内通过定向邀请行业内技术主任及以上级别专家，聚集本领域具有实际推动力、走在技术创新最前沿的发言体以及相关标准的制定者，共同讨论政策、标准法规和新技术，从而更快速有效地促进新技术在标准的研究和制定中的应用。

Paving regulatory road for new technology application in China

Preface

In recent years, the industry of automobile lamps and lighting has shown a rapid growth trend, along with the emergence of various new technologies and products. However, the contradiction between the rapid development of products and the lagging of standards and regulations always exists and has become more and more obvious. One of the main reasons for this contradiction is the lack of basic research to support the establishment of standards in China. The field of automobile lamps and lighting urgently needs a platform which can continually provide scientific and technical input for the development of standards.

The organizer, as the management unit of the standardization of automobile lamps, is responsible for facilitating the revision of national and industrial standards in this field. Meanwhile it would provide the exchange platform for latest technologies and academic in this field so that it can focus on these high-end, hot and innovative technologies. It makes it possible to create a platform dedicated to transforming new technologies into new standards.

This year's Sino-Europe Conference on Automotive Lighting Regulations and Standards is different from previous years. It will be closely linked to the 1st Executive Summit on International Automotive Lighting Innovation Technology and Standardization. By inviting international experts with technical strength and domestic technical managers or experts of above level in the automobile lighting industry, it will gather person who are at the forefront of technological innovation and also have political influence, and relevant standards makers, in order to discuss policy, standards and regulatory development and new technologies and their interactions, and the need for new approach to standards and regulations development. As a result the application of new technology for standard research and development can be promoted more quickly and effectively.
